- ❖ News: USDA to Invest up to \$900K for Conservation Innovation Grants that Address Florida Agriculture Resource Priorities Gainesville, FL April 15, 2022. The U.S. Department of Agriculture (USDA) today announced the Natural Resources Conservation Service (NRCS) in Florida will invest up to \$900,000 for Conservation Innovation Grants (CIG) for Florida's agricultural resource priorities. Fiscal Year 2022 conservation resource priorities for the NRCS in Florida are: climate resilience, grazing, soil health, and urban agriculture. The deadline to submit a proposal is by 11:59 p.m., Eastern Standard Time, August 31, 2022.
- **❖ Farm Bill Programs:** 19 of 55 Active contracts totaling approximately \$1,110,000 over approximately 12,000 acres.
- **♦ EQIP:** 13 Active Contracts; 9 eligible applications FY 2022 applications (2 Preapproved, 1 approved) .
- ❖ CSP: 6 Active Contracts, 2 FY 2022 applications.
- **❖ ACEP-WRE**: 1 application.
- **❖** Conservation Applications: April May
  - 10.3 ac Irrigation Water Management.
  - 1 Livestock Water Well.
