2. ADDITIONS/DELETIONS TO THE AGENDA/EMERGENCY ITEMS:

Robert C. Adair, Jr, Chairman read the <u>CONSTITUTION OF THE STATE OF FLORIDA</u>, ARTICLE II GENERAL PROVISIONS SECTION 5. Public officers.

"(b) Each state and county officer, before entering upon the duties of the office, shall give bond as required by law, and shall swear or affirm:

"I do solemnly swear (or affirm) that I will support, protect, and defend the Constitution and Government of the United States and of the State of Florida; that I am duly qualified to hold office under the Constitution of the state; and that I will well and faithfully perform the duties of <u>(title of office)</u> on which I am now about to enter. So help me God.", and thereafter shall devote personal attention to the duties of the office, and continue in office until a successor qualifies.

SECTION 7. Natural resources and scenic beauty.—

(a) It shall be the policy of the state to conserve and protect its natural resources and scenic beauty. Adequate provision shall be made by law for the abatement of air and water pollution and of excessive and unnecessary noise and for the conservation and protection of natural resources."

 - ❖ No Report.
- C. Matthew Cox, Environmental Specialist III, Office of Agricultural Water Policy-Florida Department of Agriculture and Consumer Services (OAWP-FDACS) Report:
 - ❖ Continuing with Implementation Verifications (IV's) with agricultural producers.
- D. Eric Charest, Interim Natural Resources Director
 - ❖ Indian River County Central Indian River Lagoon Basin Management Action Plan Presentation
 - ❖ The Central Indian River Lagoon Basin Management Action Plan (BMAP) was established to require local governments, agencies and stakeholders to reduce nutrient loads (Total Nitrogen (TN) and Total Phosphorus (TP)) to the Indian River Lagoon.
 - ❖ include only portions of the County that drain to the IRL
 - ❖ IRC falls within 2 Segments: IRL SEB and IRL B
 - ❖ The County's efforts to improve the health of the Indian River Lagoon (IRL) began in 2002 pre-dating the State's 2009 Total Maximum Daily Load (TMDL) and the 2013 Basin Management Action Plan (BMAP) programs
 - ❖ Coordinated efforts of multiple County Departments:
 - Public Works (Coastal and Stormwater)

- Utilities
- Conservation Lands
- Community Development
- Natural Resources Department
- Indian River County Progress:
 - Stormwater-Stormwater treatment facilities, PC Main, Harvesting of water lettuce, Education and Outreach
 - Utilities: Septic to Sewer, Advanced wastewater
 - Current efforts represent more than \$80 Million in investments to date
 - Operation & Maintenance does not qualify for additional credits
- ❖ The County continues to pursue projects that benefit the Lagoon, with a focus on many water quality improvements that also count towards the County's BMAP reduction requirements. Those projects include:
 - Septic to Sewer Projects
 - Baffle Box Installations
 - Outfall Treatments
 - Lost Tree Island Conservation Area
 - A1A Shoreline Enhancement
 - Flood Studies and Flood Protections
 - Seagrass Pilot Plan and Restoration Projects
 - Muck Assessment and Removal
- Per Section 403.067, F.S., when DEP adopts a BMAP that includes agriculture, it is the agricultural landowner's responsibility either to implement BMP's adopted by Florida Department of Agriculture and Consumer Services (FDACS) to help achieve load reductions, or to conduct water quality monitoring pursuant to Chapter 62-30, F.A.C. Landowners that do not enroll in the BMP program or conduct water quality monitoring are referred to DEP for enforcement action. To date, the FDACS Office of Agricultural Water Policy (OAWP) has adopted BMP manuals by rule for cow/calf, citrus, vegetable and agronomic crops, nurseries, equine, sod, dairy, poultry, and specialty fruit and nut operations.
- Indian River Lagoon Protection Program:
 - Onsite sewage treatment and disposal systems (OSTDS)
 - Beginning January 1, 2024
 - Prohibits new OSTDS in BMAPs where sewer is available
 - When sewer is not available, requires enhanced nutrient-reducing OSTDS achieving at least 65% nitrogen reduction
 - By July 1, 2025
 - Commercial and residential property with an OSTDS within a BMAP must connect to sewer where available
 - When sewer is not available, requires upgrading to enhanced nutrient-reducing OSTDS achieving 65% nitrogen reduction
 - Advanced wastewater

E. Linda Caggiano, Staff Assistant II:

- **FDACS:** Contract 27690: Amended 10/17/2023 \$15,041.26 due to Audit Cost. No Updates/Changes since November report.
- ❖ <u>FCDEA</u>: Next meeting scheduled Tuesday, December 19, 2023. Will be reviewing other SWCD's website to see if in compliance due to OPPAGA. No mention of any Districts being contacted by OPPAGA. No mention of any legislators filing any bills to dissolve SWCD's in Florida.
