## C. Stephen Wright, Environmental Specialist II, Office of Agricultural Water Policy-Florida Department of Agriculture and Consumer Services (OAWP-FDACS) Report:

Studying BMP Manuals to improve small farms. Suggestion to the Board for improvement to Cost-Share: Soil and plant tissue testing is challenging for smaller producers in the area. When enrolling the producers on the small acreage; schedule the soil and tissue testing for the next 24 months If there was a way to provide soil testing kits for small farmers. UF IFAS has a soil test but targeted for homeowners.

#### D. Linda Caggiano, Staff Assistant II:

- **FDACS:** Contract 27690: Amended 10/17/2023 \$15,041.26 due to Audit Cost. \$115.041.26 for 2023-2024; Paid out a total of \$55.193.32; \$32.504.98 from prior year and \$22,688.34 current FY 2023-2024. 4 Cost-Share Agreements pending receipt of RFR's totaling \$48,155.64. Balance available of \$21,783.57 for FY 2024 Cost-Share FY 2023-2024. FDACS will reimburse IRSWCD for the full \$8,000.00 for audit per email 12/18/2023 @ 10:00 A.M. FDACS plans to send out letters that will state that the land owner MUST contact the Office of Agricultural Water Policy-Florida Department of Agriculture and Consumer Services' or they will be fined by DEP. (Prior letters were maybe fined.) FDACS is also working on another project that will allow Producers/Farmers to sign-up for Cost-Share online. If they are not enrolled in an FDACS Program it will let the Producer know and the system will notify the FDACS Environmental Manager for that area to reach out and visit that Producer. N. West Gregory, Direct has instructed the FDACS Manager to update ALL BMP Manuals by end of 2024 calendar year. The manuals are to be streamlined, clear and concise. The FDACS committee to review the Managers updated manuals cannot just strike information they must put in what should be replaced, not making the Mangers guess what should be written. All the rules and requirements are to get the manual completed by deadline. Create a Small Farm BMP Manual for Greenbelt/Agricultural Exempt land use with small farms that does not apply/fit any other manuals. It will be a catch all manual. Once manuals are updated, DEP will review. Legislature to approve to move to Rulemaking, not part of Florida Statutes.
